Discussion of priority items:

Residency requirements for concentrations:

- We should contact the stakeholders in this discussion and get their input.
- We need to distinguish between optional versus required concentrations.
- Some accrediting agencies are requesting a change from "concentration" to language like "tracks" or "areas of study".

Attendance policies:

- Various problems were identified, including conflicts between course management and messaging from the Associate Deans, significantly increased levels of absenteeism over the last few years, students leaving early for breaks, faculty canceling classes, and the complex interaction of class attendance and mental health issues.
- It was noted that there exist attendance requirements (attendance verification) for financial aid and that that we need to be cognizant of these to ensure compliance.
- Proposed that we should view this topic as composed of three parts: college policy, instructor autonomy, and the responsibility of Associate Deans in the attendance verification process.
- Some colleges perform an enrollment verification process during the first week of classes.

	 Discussion about how attending classes may be good for students who are struggling and how missing additional classes can compound stress. We could consider doing a sandwich seminar on the subject. No matter what we do, we should involve the SGA in these discussions. 	
	Selection of a meeting time for the 2022-2023 year: 10 AM was identified as the optimal time	No objection. 10 AM selected as the official EPC meeting time.
	Selection of meeting location for the 2022-2023 year: Discussion of the benefits to meeting in person and the disproportionate inconvenience of meeting in person. A compromise was struck where the first meeting will be in person (likely at the conference room in Miller), with options for hybrid meetings thereafter.	First meeting in person, following meetings will have a hybrid option.
