Writing Intensive Courses	Carol Van Der Karr discussed a compliance issue for federal and state financial aid and new software that is requiring that we structure some of our curriculum in Banner a bit differently to help ensure that students are appropriately in compliance and receive the aid they are eligible for each semester. One of the solutions revolves around writing intensive courses. Currently, we put the attribute on at the section level of the semester schedule as the WI is fluid. We now need to have that at the course level in order for the courses to translate into the new system. Since the WI attribute is assigned at the section level (i.e., sections of the same course may or may not be WI), this is causing technical/communication issues between banner, Degree	Nancy, Jennifer, and Zachary (Advisement and Transition) will meet to discuss possible impacts of this process.

	Works, and financial aid. To solve the issue without changing a campus policy, it was proposed that we should create cloned versions of courses (i.e., writing intensive sections and non-writing intensive sections will now have different course numbers). UCRC approved the proposed process to allow for Writing Intensive attribute to be placed on the course level and create a cloned course that would not be writing intensive. Departments will be consulted, along with Advisement and Transition regarding the implementation of this change.
