<p><b>Excellence in Teaching Award—Tenure Track</b>            This award is presented to the faculty that has been determined to have superior classroom performance. The nominee must maintain a flexible instructional policy that adapts readily to student needs, interests and problems. Mastery of teaching techniques must be demonstrated and substantiated. Full time tenured teaching faculty with at least four semesters of teaching at SUNY Cortland are eligible.</p>	October 7	Fall/Spring Observations	\$1000	Administered by the Faculty Development Committee that serves as the peer review body for awards. <p><b>Excellence in Teaching Award—Non-Tenure Track</b>            This award is presented to the faculty that has been determined to have superior classroom performance. The nominee must maintain a flexible instructional policy that adapts readily to student needs, interests and problems. Mastery of teaching techniques must be demonstrated and substantiated. <p><b>Brooks Internationalized Curricular Development Award</b>            This award supports curricular development of a new (semester-long) course that contains a significant international curricular component. Eligibility is open to tenured and untenured tenure-track faculty (carrying a full-time teaching load) at the undergraduate level who have completed at least eight semesters of teaching at SUNY College at Cortland prior to the year of application.</p>	September 3	October 1	\$3500	Administered by the Faculty Development Committee. <p><b>Rozanne Brooks Dedicated Teacher's Award</b>            This award is presented to individuals who are outstanding teachers in the classroom, who spend considerable time with students and are very student oriented. These teachers are also active and worthwhile participants in the business of the College and involved with curriculum. Eligible applicants include full time faculty who hold continuing appointment for at least five years and have taught a full course load as determined in his/her department in both fall and spring semesters.</p>	October 7	December 1	\$5000	Information will be forthcoming under separate cover about the competition and criteria.

<p><b>Dr. Peter Di Nardo '68 and Judith Waring Outstanding Achievement in Research Award</b> This named award will be given to a faculty or professional staff member whose record of research achievements are deemed outstanding among others on campus. The Awardee will be selected based upon at least five years of research related activities at SUNY Cortland and are full time tenure track faculty (including library faculty) and professional staff members. <p><b>President's Award for Funded Research</b> This award is given in recognition of faculty or professional staff achieving \$1,000,000 in externally sponsored funding in recognition of their efforts to cultivate and administer large-scale and impactful projects at SUNY Cortland. <p><b>Outstanding Achievement in Mentoring Undergraduate Research</b> This competitive award will be given to faculty or professional staff members whose record of mentoring undergraduate research or creative activity are deemed particularly outstanding. Full time tenure-track faculty (including library faculty) and full time lecturers whose responsibilities include at least 50% teaching are eligible, along with nominees having directed or mentored at least two undergraduate student research or creative projects.</p>	October 7	February 17	\$750	Administered by the Undergraduate Research Council that serves as the peer review body making recommendations for an awardee to the Provost. <p><b>Outstanding Achievement in Faculty Service Award</b>            This award is presented to faculty whose record of service is deemed outstanding among others on this campus and is above and beyond what constitutes normal service activity at the College. Such excellence in service shall be defined as a distinguished level of service sustained above the normal expectation for advancement in rank. Eligible candidates include full time teaching faculty (including librarians and f/t lecturers) whose responsibilities include at least 50% teaching and have been employed at SUNY Cortland for at least five years.</p>	October 7	Feb 5 nominations  February 19 packet of materials from candidates	\$1000	Administered by the Research and Sponsored Programs Office on behalf of the Provost Office. <p><b>Excellence in Academic Advising</b>            This award is given in recognition of the significant aspect of faculty roles and responsibilities. Nominee must demonstrate excellence in student advising and exemplify the criteria listed. <p><b>Excellence in Professional Service Awards</b>            This award is given in recognition of professional excellence in achievements for institutional service, innovation within a profession, exemplary service to students, or a combination thereof. Must be active full-time for the previous academic year who provide a positive impact on students outside the classroom, establish and/or maintain opportunities for student involvement outside of the classroom, and demonstrate that they have 'gone the extra mile' in order to serve students.</p>	January 4	February 15	Plaque and recognition at Awards Ceremony in the spring	Nominations will be reviewed by the Student Affairs Faculty Connection Award Committee and a recommendation is made to the Vice President for Student Affairs.
