## **RATIONALE:**

**WHEREAS** the Distinguished Professor designation constitutes the highest system tribute conferred upon SUNY faculty; and

**WHEREAS** the Distinguished Faculty Rank programs encourage ongoing commitment to excellence, kindle intellectual vibrancy, elevate the standards of instruction and enrich contributions to public service; and

**WHEREAS** all four Distinguished Professorship ranks should reflect sustained outstanding service to the State University of New York.

## **RESOLUTION:**

**THEREFORE BE IT RESOLVED** that the University Faculty Senate recommends that the Chancellor adjust the criteria for promotion to distinguished professorships to read: "Candidates for all four Distinguished Professorship Ranks must have held the rank of Professor or Librarian for at least five years (including time in rank at non-SUNY institutions) and must have at least three years of full-time service at the nominating institution."
