#### **SUNY Senator:** A. Fitz-Gibbon:

- Attended the CGL Conference with the SUNY Faculty Senate over this past weekend, 10/20/17-10/23/17, where he met the new SUNY Chancellor.
- Reported that the new SUNY Chancellor is very interested and involved with promoting shared governance.
- There were several resolutions passed at the conference, and are as follows:
  - o Recognizing Indigenous Peoples' Day, as opposed to Columbus Day
  - Free access to menstrual products in *all* restrooms on campuses

- Academic advising and financial aid faculty advisors should refer students to financial aid office in regards to scholarships and other financial questions, rather than advising students themselves on such matters
- United States military personnel Attendance Policy Accommodation for United States Military Drills and Training
- On 10/11/17, the Board of Trustees passed a resolution that allows charter schools to implement their own accreditation for teacher education; this was vehemently opposed by the University Faculty Senate

#### **Student Senator:** A. Arkayasa:

- Reported that the SGA leaders have been building relationships with new students, particularly freshmen and transfer students
- Explained that SGA is eligible to receive the SUNY Shared Governance Award, if a faculty member nominates them; the deadline for nominations is 11/21/17
- A. Arkayasa nominated Sophie Umansky to serve on Faculty Senate as an SGA representative

  - O Vote: 17 to 4; motion approved
- L. MacDonald made a motion to strike entire second sentence of the first paragraph, beginning with the term "Likewise..." which was seconded by A. Arkayasa:
  - O Vote: 8 to 15; motion failed
- R. Borden made a motion to amend "...with dignity and with respect to age, ability or disability, ethnicity..." which was seconded by A. Arkayasa;
  - o Vote: 23 to 0; motion approved
- G. Rinefierd made a motion to amend "...this commitment or its expression in this course..." which was seconded by A. Blavos:
  - O Vote: 7 to 14; motion failed
